  While existing literature has identified many of the factors that influence individual behavior when it comes to reporting corporate fraud, most models ignore or undervalue the role that self-driven motivation plays in the decision making process. Applying recent findings in the donation literature to the field of accounting, we propose to show that while the common conception is that whistleblower's are altruistic individuals, the ultimate decision is more strongly driven by self-motivated emotions and attitudes.

  Exploratory research to create a framework of the impact of Aspergers and Narcissism on accountants' work output.
- "Inadvisability of Metaphorically Conceptualizing Students as Customers" (Planning). Students are often conceptualized as customers, but students are <u>not</u> customers in the traditional sense, so common use of this conceptual metaphor has incited considerable controversy. This project will deconstruct the 'students as customers' metaphor habitually engaged by administrators and faculty as a cognitive frame for institutional thought, rationale, and policy re university students. "The Effects of Expanded Analyst Ownership Disclosure on Nonprofessional Investors'
Judgments and Decision-Making (Dr. Robert Marley & Dr. Mark Mellon)" (On-Going).
This study examines the effects of expanded analyst ownership disclosures on
nonprofessional investors' confidence in analyst recommendations and on their subsequent
capital allocation decisions. In an experimental setting, nonprofessional investors received an
analyst investment recommendation that contained a disclosure with information regarding
the magnitude and duration of the analyst's ownership position in the recommended stock.
Applying attribution theory's discounting principle, we find evidence of an interactive effect on
investor judgment such that investors who receive a disclosure that the analyst holds a large,
short-term investment position were less confident in the recommendation relative to
investors who receive alternative disclosures, including the disclosure currently required by
Title V. Further, we predict and find mediated-moderation such that disclosures affect
investors' confidence in an analyst's recommendation, subsequently affecting the amount
invested. In sum, the evidence suggests that investors find analyst ownership disclosures
informative. Implications for market regulators and practitioners are discussed.

"Two Archetype Faces Used by a Successful Narcissistic Leader (Dr. Robert Marley, Dr. Heidi Montague, & Dr. Doreen MacAulay)" (Writing Results).

Using case analysis, this study examines the effects of a successful narcissist leader's actions on his employees in a business context. Two archetypal masks are identified: the Magician and the Autocrat. Then, a discussion of how the leader wears each mask to accomplish a different purpose is presented.
