



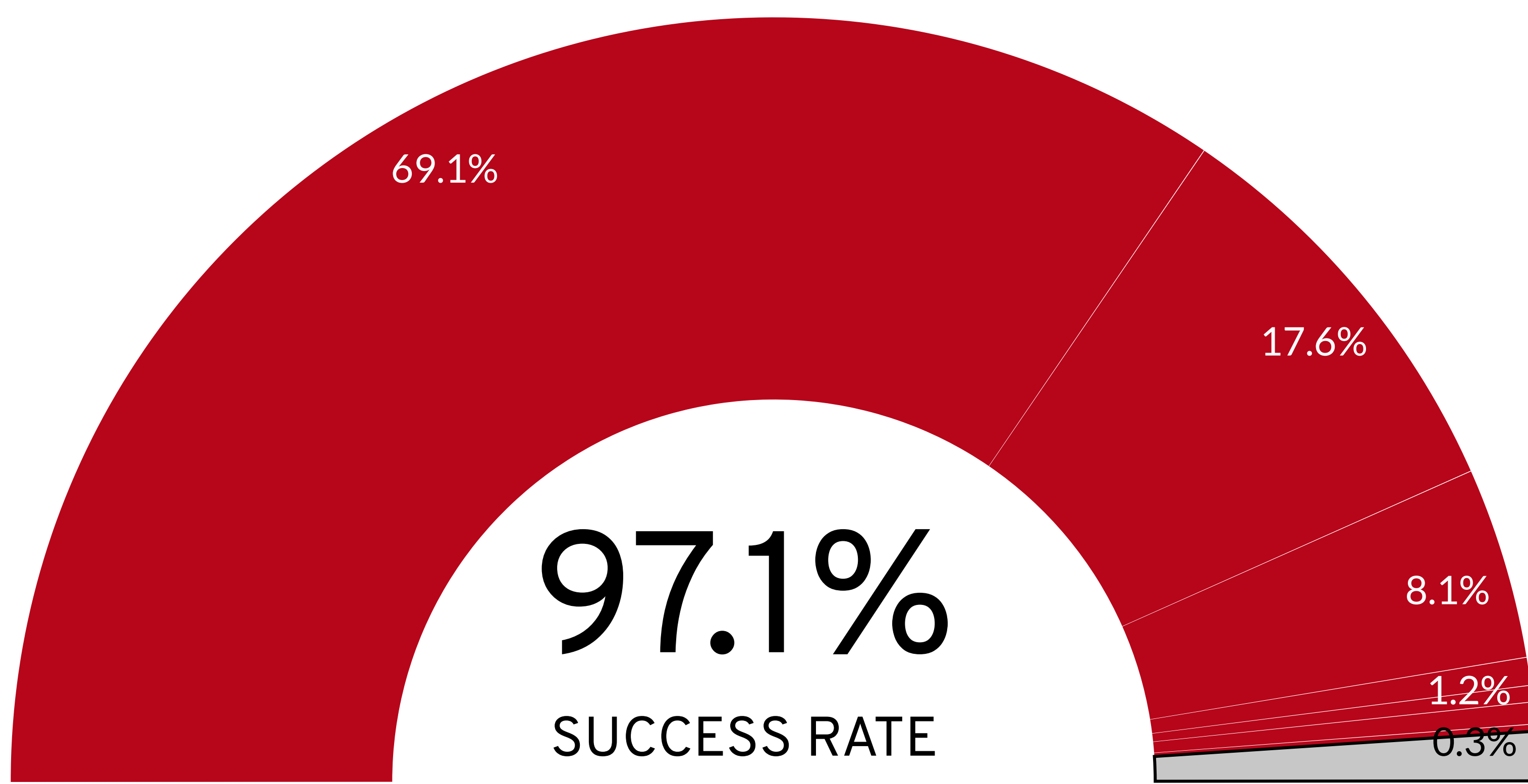
FIRST DESTINATION REPORT

Undergraduate Class of 2022

Executive Summary:

Data from sixty-two percent (61.7%) of the 2022 undergraduate degree recipients were collected from online surveys, faculty, employers, and other verifiable information sources in accordance with the National Association of College and Employers' First Destination Standards. (Data obtained for 1126 out of 1824 total graduates.)

Immediate Plans



97.1% of respondents from the undergraduate **Class of 2022** survey (May, Aug., Dec. graduates) reported success in achieving their post-graduate goals.

Class of 2022 Residency:

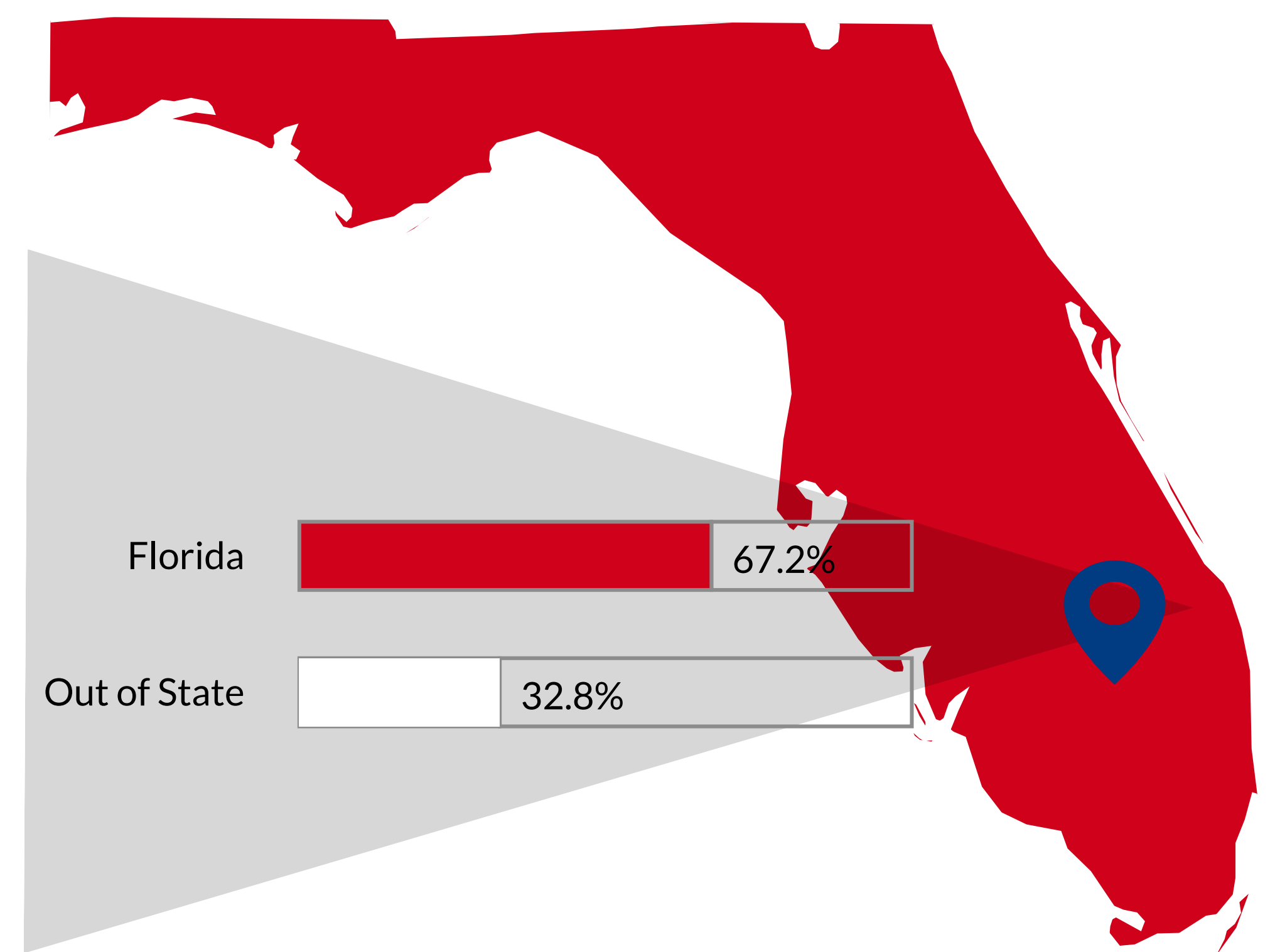
Graduates from the Class of 2022 live all across the US and internationally.

1099 of the 1126 graduates responding to our survey reported where they planned to live after graduation.

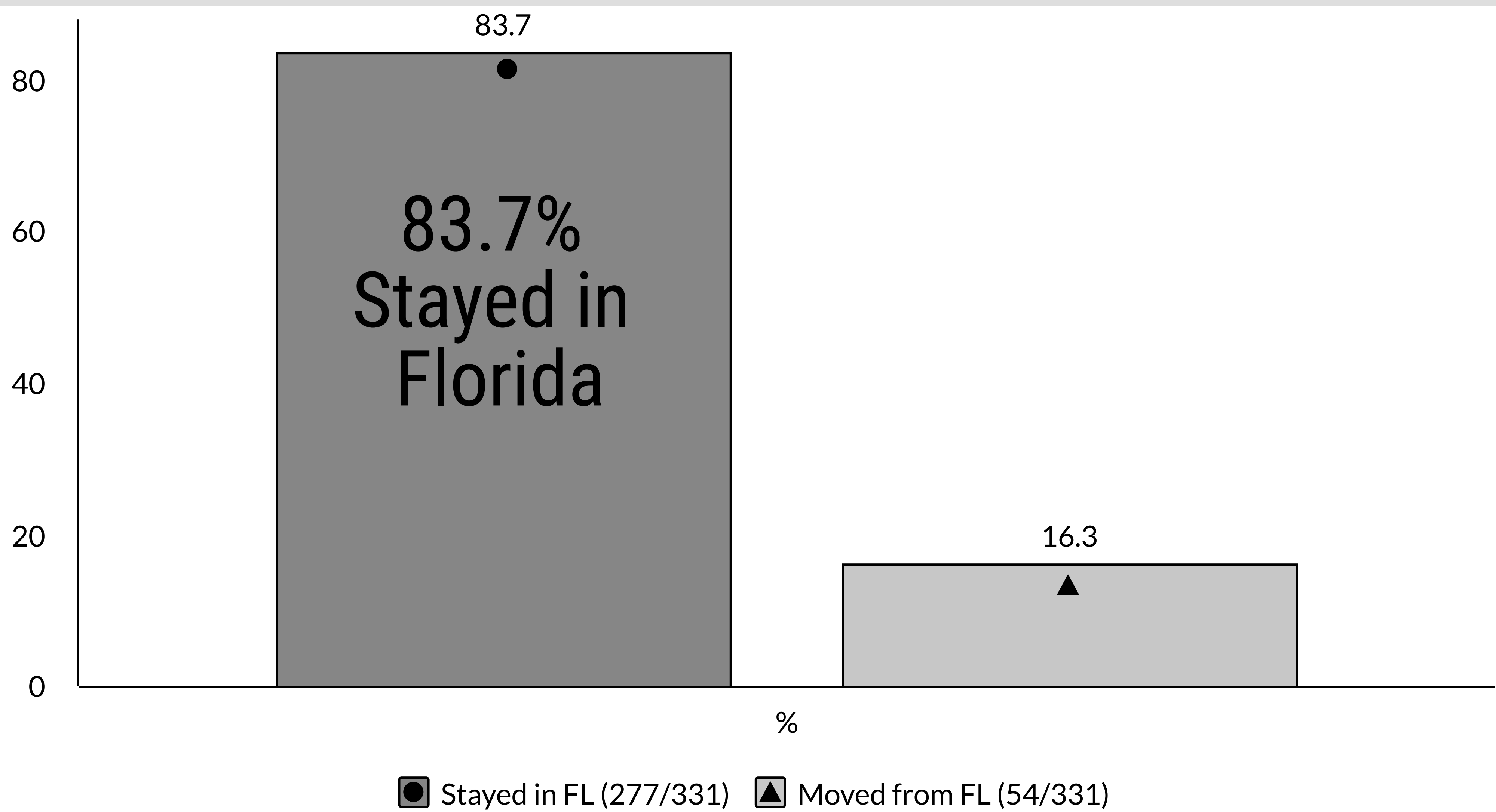

Post-Grad Residency



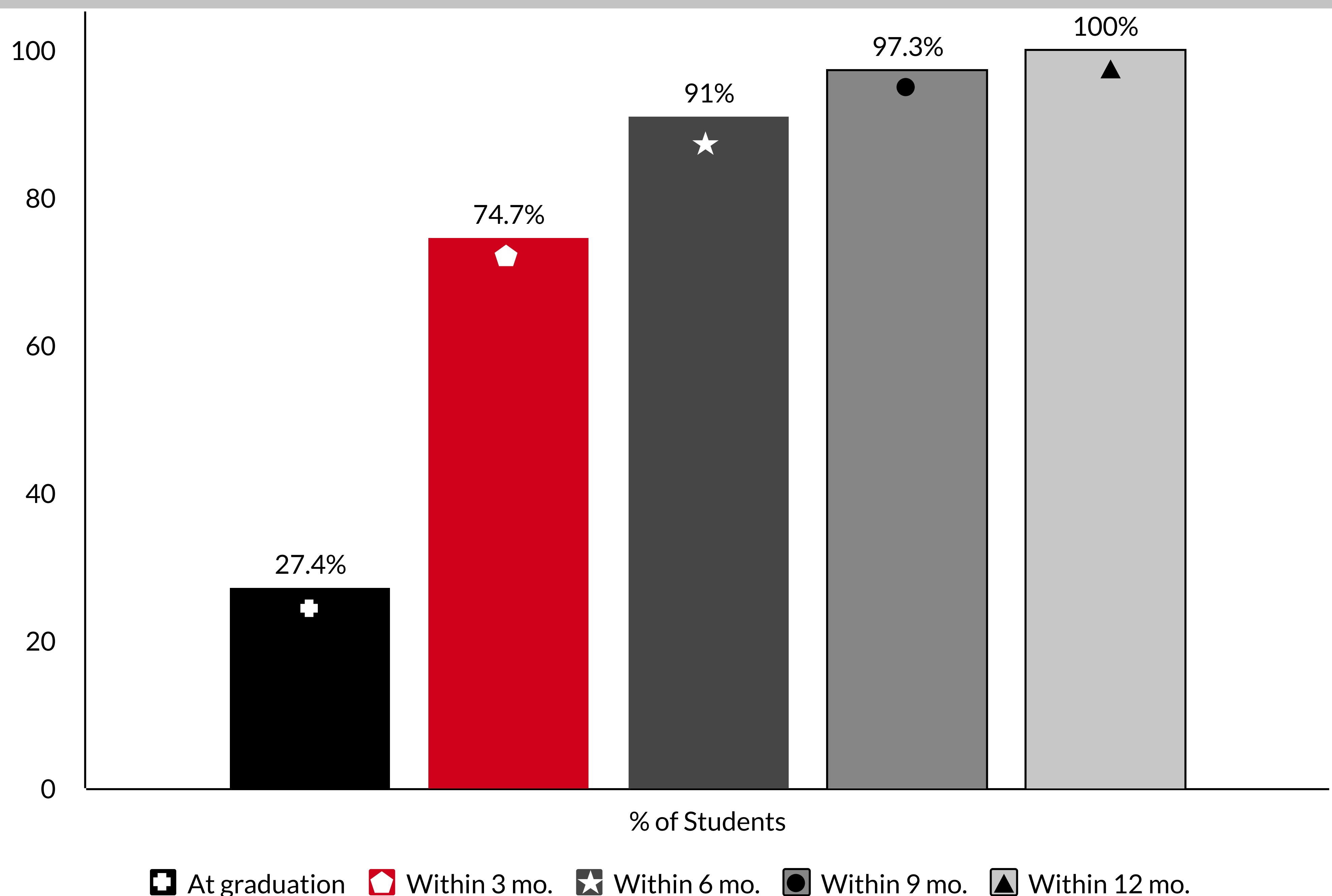
Students from Florida who Reported Full-Time Employment

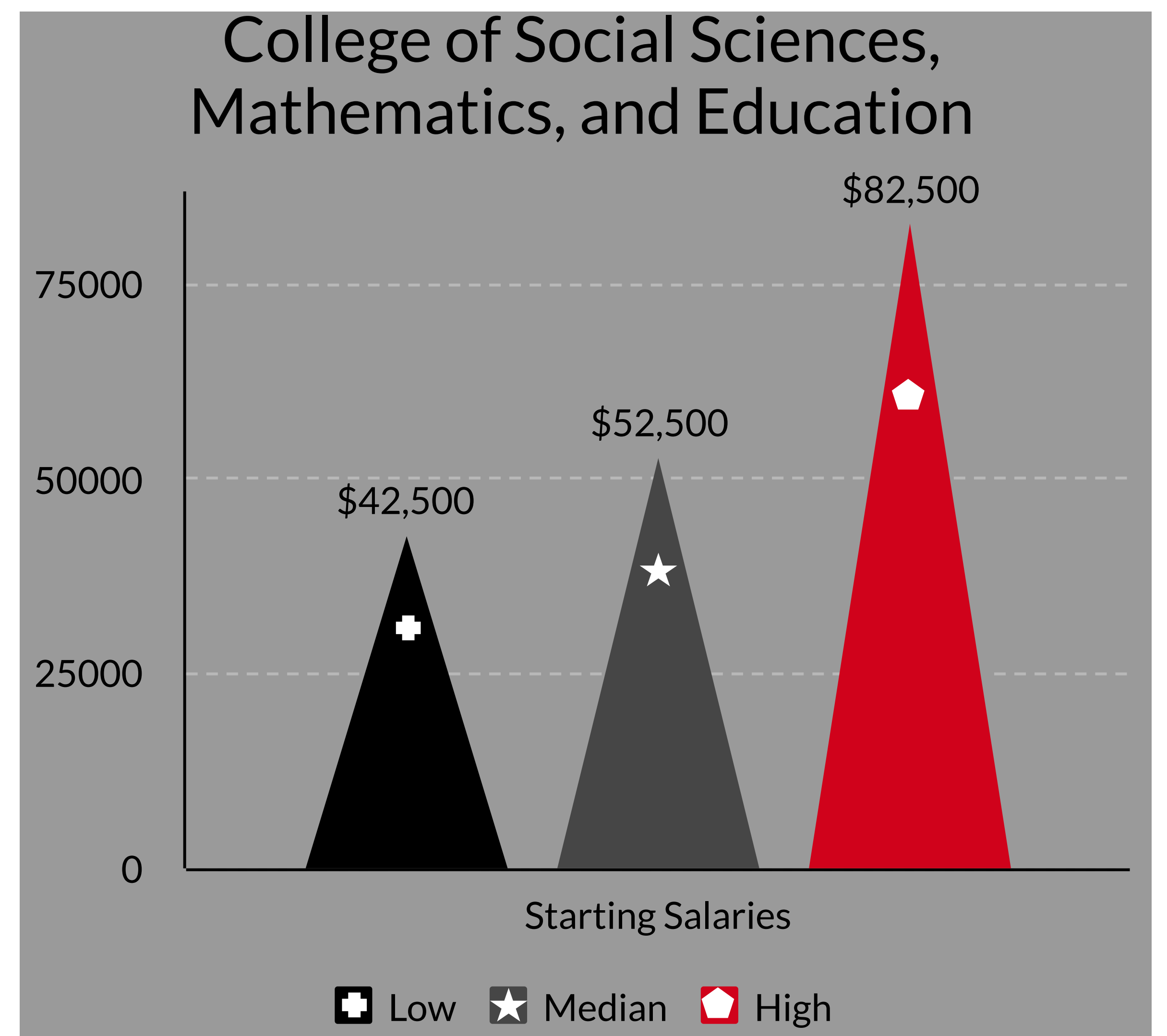
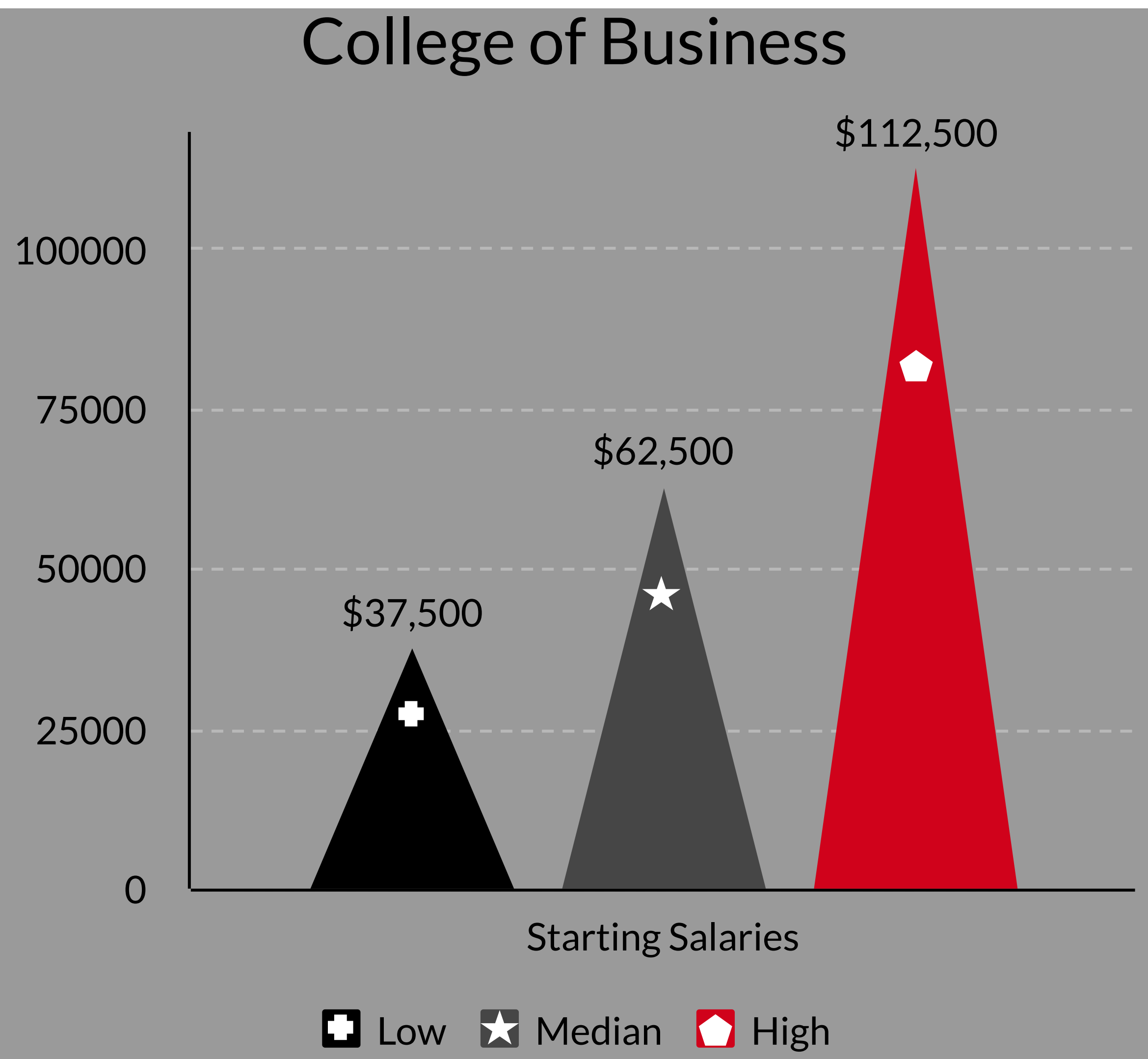
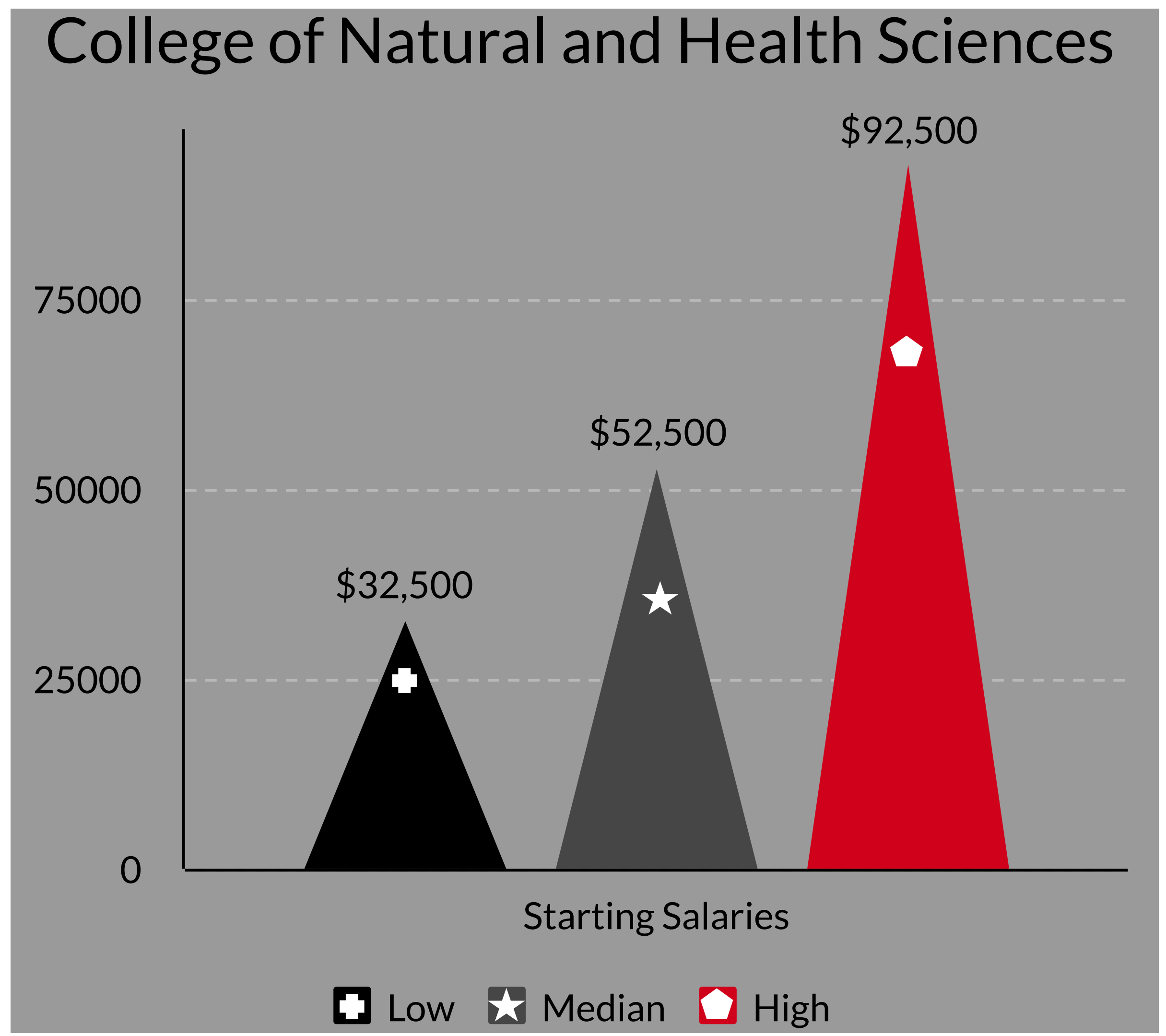
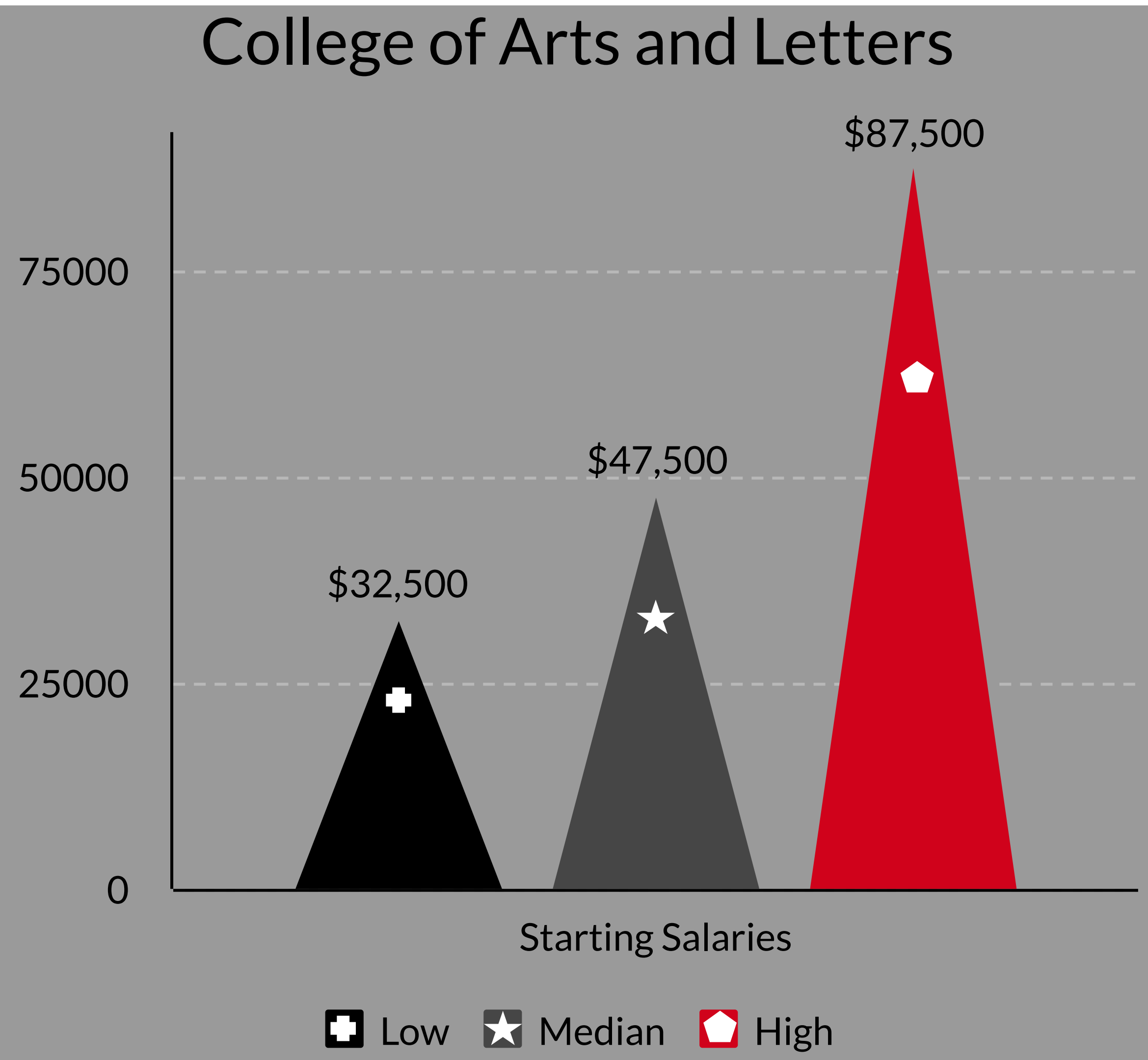
Salary Data Reported:

Average Salary

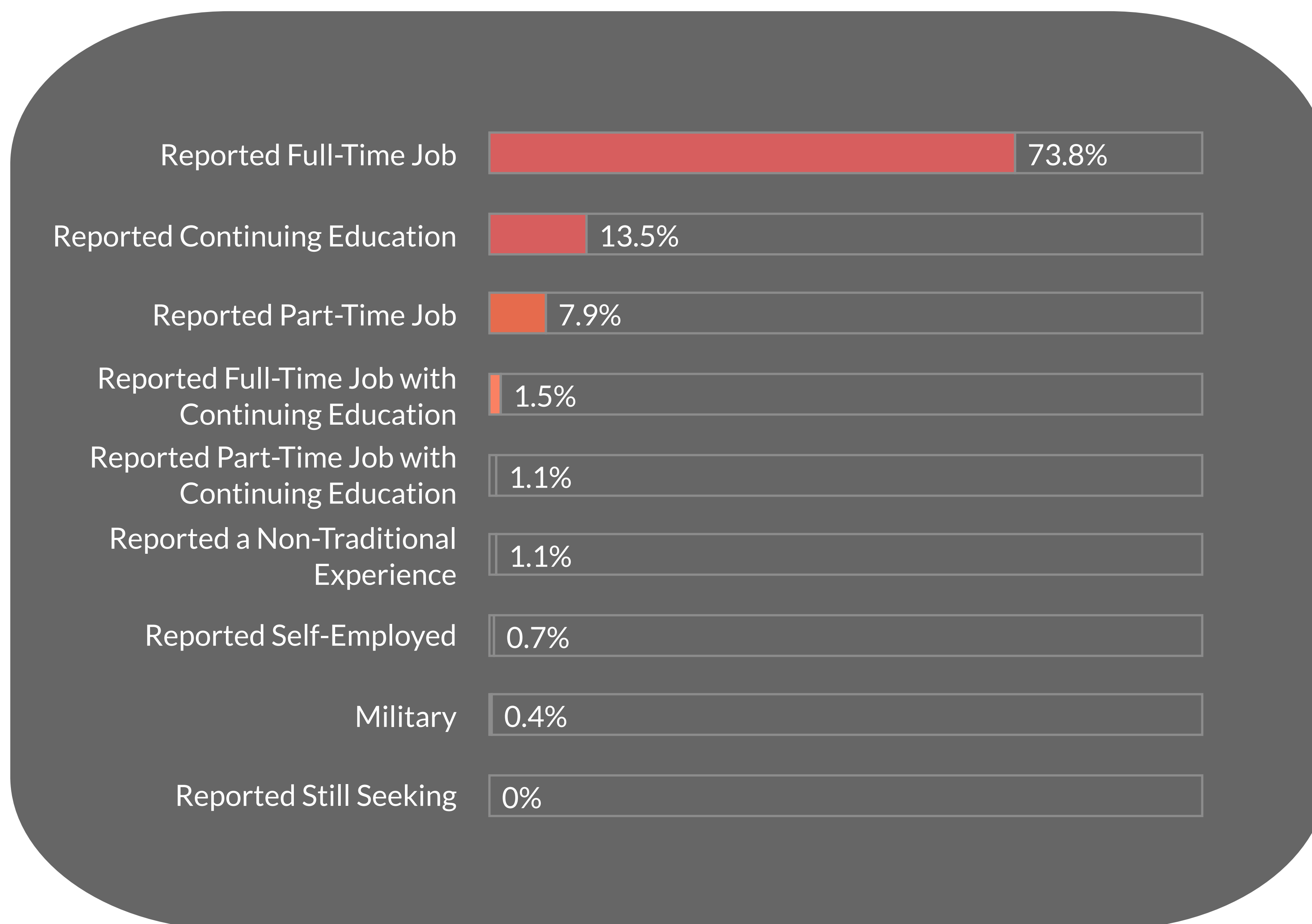


For purposes of calculating the mean, median, maximum and minimum salary information, the midpoint of the reported salary range is utilized for each respondent.
