FAQ

- Do I have to provide my full annual gift in one payment? No! You can set up recurring gifts online or through payroll deduction to make your annual gift.
- How do I set up payroll deduction? Just fill out the back of this brochure and we do the rest! Your tax-deductible gift is taken directly from your paycheck each pay period. Your gift continues each year until you change or stop it. You'll get a receipt in January for tax purposes.
- Can I direct my gift to a specific use? Yes, gifts to all areas are appreciated and have a positive impact on our University. Unrestricted gifts are preferential and offer the most flexibility and responsiveness to need.
- Can I contribute to UT's endowment? Yes! You can set up your own endowment fund or contribute to an existing endowment. The UT Development office can help you identify the best way for you to contribute to UT's endowment.
